Tort Judgments and Settlements Pertaining to WSF and Non-WSF Operations

Pursuant to ESSB 5161, Section 220 (2) & (3), of the Washington State Legislature's 2025 Transportation budget pertaining to the Washington State Department of Transportation (WSDOT), the following is a summary report of information related to tort judgments and settlements pertaining to the Washington state ferry system (WSF) and non-ferry operations of the department. This report covers judgments and settlements for quarters three and four of FY25 (January through June 2025).

To provide context, there are five general categories of cases. First, there are claims handled and settled by WSDOT per its delegated authority from the Department of Enterprise Services, Office of Risk Management. Second, there are claims and cases tendered to insurance companies wherein contractors hired by WSDOT are required to indemnify the State of Washington for claims related to work on construction projects. Third, there are cases that can be dismissed on motion by a party. Fourth, if a lawsuit cannot be dismissed on motion, an attempt is made to reach an agreed settlement. Finally, there are cases that result in a trial. All categories, whether actual litigation or not, may have defense costs relating to them as well as regular payouts. All payments made to litigants are reduced to judgments pursuant to statute codified in RCW 4.92.040 and according to the civil court rule 54(a)(1). A judgment is defined as the final determination of the rights of the parties in an action.

All tort claims received against the state are provided a unique identifying number and are classified by type. Claims are classified as personal property damage, marine vessel property damage, bodily injury, marine crew injury, civil rights, and death. Payments are separated into bodily injury (BI) and property damage (PD). The litigation costs involved in representing WSDOT are recorded as Paid Legal (PL).

The following information is the data required and responsive to Section 220, subsection 2 (a) - (c) and subsection 3 (a) - (c).

Note 1: The Average Payout Per Claim column includes both indemnity payout and defense costs and is based the number of actual claims with any payment.

Note 2: For claims classified as one type with both property and injury payments, the payments are combined as one indemnity payment within that type of claim.

Note 3: This amount includes a \$25M settlement that was paid in 8/2024 but the claim was closed during this period. Insurance paid \$5.25M of this amount.

Proviso Section 2(d) Response

Moving legal costs due to claims associated with WSF into the statewide Self-Insurance Liability Pool administered by the Department of Enterprise Services (DES), Office of Risk Management will result in increased predictability by paying those costs through the Self-Insurance Liability Pool biennial premium. Self-Insurance Liability Pool premiums are established by actuarial analysis rather than paying costs incurred throughout the biennium, the unpredictability of which is often difficult for Program U to manage. However, DES, Office of Risk Management still bills WSDOT for reimbursement of costs associated with claims filed prior to July 1, 2019. Thus, costs for all WSF claims filed prior to July 1, 2019 will be difficult to predict until all claims are resolved. For any claims filed prior to July 1, 2019 for which there is a settlement, WSDOT will keep the governor's office and legislature informed and identify the additional budget impacts.
